Paul Scharrenberg, who contributed "The Philippine Problem," is Secretary-Treasurer of the California State Federation of Labor, and one of those most active in agitation for the passage of that provision of the United States Immigration Act of 1924 which excludes Oriental immigrants from entry into the United States.

Griffith Taylor, whose views on "New Lands and Old Education" we use in this issue, was until recently Professor of Geography at the University of Sydney, Australia, and has now joined the faculty of the University of Chicago.

Dr. Inazo Nitobé, who gave us permission to publish for the first time his lecture on "The Religious Sense of the Japanese People," was formerly Professor at the Tokyo Imperial University and later Under-Secretary at the League of Nations, Geneva. He is the author of "Japanese Traits," and other philosophical and literary books and essays in English and Japanese.

CONTRIBUTORS

Dr. J. B. Condliffe, who wrote "An Experiment in Diagnosis," is Research Secretary of the Institute of Pacific Relations and was formerly Professor of Economics at Canterbury College, Christchurch, New Zealand. He here reviews some of the ills of the Pacific and considers the proposed agenda for the Institute's autumn conference in the light of a diagnostician's outline.

John Collier, who writes provocatively of the problems confronting the American Indian race in its adjustments toward a superimposed civilization, is Executive Secretary of the American Indian Defence Association, and has been for many years intimately acquainted with all phases of Indian life and with the legal aspects of Indian administration in the United States. Mr. Collier's organization was largely responsible for effecting certain Indian land reforms in Congress in recent years. The Survey Graphic says of him that he "more than any other individual has stung the conscience of America over its abuse of the Indian."

Dr. Guy H. Scholefield, who contributed the factual account of Japan's and New Zealand's new Trade Agreement, is Librarian of the New Zealand Library of Parliament at Wellington, and National Secretary of the New Zealand group of the Institute of Pacific Relations. He is the author of "New Zealand in Evolution," "The Pacific, Its Past and Future," etc.

Dr. Rokuro Nakaseko, whose review of "Nippon Shindo Ron" appears in the department, Books of the Pacific, was first Carnegie Professor of International Relations at the University of Hawaii in 1928-29. He has just this month returned to his professorship in Science at Doshisha University, Kyoto, Japan.

Galen R. Weaver, who, under the initials of G. R. W., reviewed the report of the Jerusalem missionary conference on page 141, is pastor of the inter-racial "Church of the Crossroads" in Honolulu and a special student of international affairs in the cultural fields. He was on the conference staff of the Institute of Pacific Relations in 1925 and 1927.

Dr. Herbert E. Gregory, who contributed an initialed review on page 156, is Director of the Bernice P. Bishop Museum of Polynesian Ethnology and Natural History in Honolulu and an authority on the geography of the Pacific area. He is a member of the Advisory Committee of the Institute of Pacific Relations.
